\*\* In order to receive your access card(s) per family; please be advised that the following rules apply:

- **NOTICE** that all access entries are monitored through the access card system, so all entries are recorded 24 hours a day/7 days per week.
- **NOTICE** if the facilities are damaged while you are at the facility you will be contacted for reimbursement of damages.
- **NOTICE** Children (ages 12 and under) are not allowed to participate without presence of an adult over the age 18.
- **NOTICE** Limit of TEN (10) guests per household.
- Horseplay, fighting, swearing, abusive language and/or destruction of Community property are prohibited throughout the recreation center area.
- All debris must be disposed of properly, in the proper containers.

- Please be courteous to the staff and other members when using the facilities.
- Village of Oak Lake HOA is not responsible for personal belongings of members, if lost or stolen.
- Village of Oak Lake HOA is not responsible for any kind of injury while using the facilities.

**INDIVIDUALS NOT ADHERING TO THESE POLICIES MAY BE BARRED FROM THE USE OF THE FACILITIES. MANAGEMENT RESERVES THE RIGHT TO REVOKE THE USE PRIVILEGES OF ANYONE WHO VIOLATES THE RULES.**

If you wish to purchase a secondary card, you may obtain a second card by making a check payable to: **Village of Oak Lake HOA** in the amount of \$25.00 (per card) in order to obtain the second card. *(Limit 2 per household)*

If your card is lost or stolen, you may obtain a replacement by making a check payable to: **Village of Oak Lake HOA** in the amount of \$25.00 (per card) in order to obtain the replacement card(s).

Should your access card be de-activated and will then need to be re-activated for violations of published rules or any reason, there will be a \$10.00 service charge, a check made payable to **Sterling ASI**.
